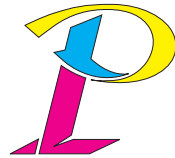

As additional time is required for the Placing Agent to procure investors to subscribe for the Placing Shares, the Company and the Placing Agent, after arm’s length negotiation, entered into a second supplemental agreement to the Placing Agreement on 24 July 2023 (the “**Second Supplemental Agreement**”), whereby the parties agreed to extend the Long Stop Date from 24 July 2023 to 14 August 2023 (or such later date as may be agreed between the Company and the Placing Agent).

Save and except for the aforesaid change, all the terms and conditions of the Placing Agreement (as supplemented by the First Supplemental Agreement and Second Supplemental Agreement) remain unchanged and continue in full force and effect. Shareholders and potential investors of the Company are advised to exercise caution when dealing in the Shares.
